There were 38 Full Member Federation with the right to vote presented at the 2017 General Assembly in Bahrain.

As per IMMAF statutes the quorum had been reached and Assembly was able to commence.

The chairperson CEO Densign White declared the General Assembly the official opening of the at least one third 1/3 of the member national federations were presented and a 3 different continents were present.

### 1. Opening of the meeting

President Kerrith Brown gave an opening speech, thanking the delegates in attendance for their commitment and the hospitality of the hosts, the Bahrain MMA Federation (BMMAF). Mr. Brown reminded all that IMMAF's vision is to unite and become an Olympic sport.

In addition, additional updates moving forward were highlighted, such as youth regulations and potential youth championships, plus obstacles faced within GAISF (Sport Accord). – reminder of the goal to present 1 application in 2018, negotiations ongoing with WMMAA.

## 2. Activity report

CEO Densign White presented an overview of all key activities undertaken in the past 12 months and how outcomes will influence decisions moving forwards, including:

- Addition of new, non-executive board members.
- Bronze membership with the Sport Integrity Global Alliance (SIGA)
- Expansion of membership: 5 new federations welcomed in 2016 taking the total to 68 with a further 10 being processed.
- IMMAF leadership engages with key figures at the SportAccord convention in Aarhus. IMMAF faces political obstacles within GAISF (formaly SportAccord), presenting the need for WMMAA merger.
- Sport Development: Implementation of IMMAF Talent Development System to create safe pathways for and structure for MMA participants
- Events calendar: Participation at IMMAF championships continues to expand, 2018 events calendar will see the addition of Junior championships, Oceania Championships and potential grand prix/exclusive events for the top 10 ranked nations, for example.
- IMMAF transitions to welcome new UFC parent company - WME | IMG - as investment partners and primary sponsor.
- Additional partners thanks: SAFE JAWZ, Green Hill, MyNextMatch, Midpoint, Safe MMA and Extreme Sports Channel.

Greece – due to lack of communication

#### **5. WMMAA merger negotiation mandate for 2019 Assembly.**

- Russian delegates requested further information as to the terms of said merger and how it would affect domestic rivalries between WMMAA and IMMAF members. Further details not applicable at this time on an official level.
- IMMAF CEO answered questions from Russia, Brazil and Czech Republic – explaining that the perceived understanding would be to encourage domestic unity (for nations that have both an IMMAF and WMMAA member). If unity cannot be achieved then the united world body would be forced to recognize the strongest domestic entity, that which has government recognition.
- Approval given for letter of intent following clarification from Mr White and director August Wallen: The General Assembly is giving permission for negotiations only; all final decisions are to be approved future assembly vote.
- 7 abstentions from voting, 38 in favor

Mr. White announced closure of the Assembly.
